The reduction in profit for the Quarter Ended 30th June, 2023 in comparison to the corresponding quarter is mainly attributable to reduced Exchange Rate Gain under the head Other Operating

Income. If the Profit from Operations is considered without the Exchange Rate Gain in both the comparable quarters, the Operating margin has improved from 5.45% to 5.96%. As the Company's business activity falls within a single primary business segment, the disclosure requirements of Accounting Standard (Ind AS-108)" Operating Segments", are not applicable. Since the Company's business relates to Micronutrient Fertilizers, Plant Nutrient Solutions etc. the same is impacted by cropping pattern, seasonality and erratic weather conditions across the

Globe in general and India in particular. Accordingly, quarterly figures are not representative of the full year's performance.
